Hi Bryce

I have reviewed the below documents in the context of the *National Environmental Standard for Assessing and Managing Contaminants in Soil to Protect Human Health (NESCS)* and Chapter E30 of the Auckland Unitary Plan (Operative in Part) (AUP OP) –Contaminated land:

- Application for land use consent for vehicle dismantling facility, associated earthworks and stormwater management 395 Fitzgerald Road, Drury (Saddleback, 6 May 2025) (AEE)
- Site Plan
- Detailed Site Investigation -395 Fitzgerald Road, Drury (Babingtons, 30 April, 2025) (DSI)

The AEE shows that the proposal relates to construction of new warehouses and associated bulk earthworks within the Future Urban zone to establish a vehicle dismantling and storage activity. The AEE has assessed the change of use from a horticultural site to the proposed commercial land use is a permitted activity under the NESCS and chapter E30 does not apply based on the DSI findings.

The DSI comprised a review of historical aerial photographs, available geology and hydrology maps, certificate of title, Auckland Council Contamination Enquiry and property files, other public available information, a site walkover, soil sampling and testing of the site. The DSI shows that the site has been subjected to horticultural activity including greenhouse likely since at least 1996. No chemical or fuel storage was observed on the site. The DSI shows that a total of 20 surface topsoil samples and a further 5 samples (0.5m bgl) were collected from across the site (excluded the inside of the greenhouse) and tested for contaminants of concern including heavy metals, organochlorine pesticides, hydrocarbons and asbestos. The test results show contaminants were recorded either below the background concentrations or under the laboratory reporting limits.

I have also double checked the Retrolens and Geomap, which indicate the horticultural activities on the site have been occurring in relatively recent years. Although no testing was undertaken inside the greenhouse, the soil testing in the horticultural fields does not reveal any issues of concern. I therefore consider that regulation 5 (9) of the NESCS applies to the site. Since the site is not a piece of land covered by the NESCS, the NESCS nor rule E30 applies.

No further information relating to soil contamination is required.

I will provide you feedback on hazardous substances under E31 separately.


