Another week has gone by, and we have still not received a response to our question that we first asked almost two months ago. Is it Government policy to require our Council to remove our Special Character Areas or not?

In the meantime, the Panel hearing submissions has issued another Minute dated 16 December 2024

We are very concerned to see that the Panel says :

"As matters presently stand, the PC 78 process is required to be completed in time for the Council to finalise its decisions on the Plan Change in time for notification on 31 March 2026. This will require the Panel to commence alternative dispute resolution in March 2025 and commence the hearing of submissions by May 2025, to be able to finalise its recommendations to the Councilby late 2025."

We do not see how we, our member groups, or any of the other thousands of submitters, can sensibly prepare for and engage in alternative dispute resolution in March, and hearings from May when neither we nor the Panel know:

- 1. Whether the Minister is going to try to make Council remove all or some of our Special Character Areas.
- 2. Whether or not Council will be removing the MDRS for some or all areas:
- 3. What proposals Council is going to put forward in its Variation re-zoning the former Light Rail Corridor Area;
- 4. What areas Council is going to propose be excluded from intensification in its Natural Hazards Variation.

Would you please confirm urgently that the Minister will be granting an extension of the timeframe for completing this process?
